REVISED SUMMARY: On May 7, 2002, the Board of County Commissioners held first reading on this ordinance and directed staff to bring the ordinance forward for final adoption. The proposed changes include a requirement that the total membership represent labor (organized labor or trade association); financial (banking or similar institution or tax or financial professional, such as attorney, accountant or financial planner); commerce (business owner or representative or business organization representative); and low income or affordable housing advocates (resident of affordable housing, representative of non-profit organization that advocates on behalf of low-income persons for affordable housing or real estate professional specializing in affordable housing. A term limit of two (2) consecutive four (4) year terms is proposed as well as a limit of two (2) consecutive one (1) year terms for the Chairperson.
