Immediately following today's meeting FSU will do a final review of their BCC presentation for any interested members and staff.
- B. The Video and Audio Class of the Northwood Youth Empowerment Center has won the Fair Housing Contest of The Realtors® Association of the Palm Beaches and the Palm Beach County Office of Equal Opportunity. The group got third place last year.
- C. Congratulations to Wendy Sartory-Link and Barbara Cheives. Ms. Sartory-Link, former CJC Chair and member for nine (9) years was awarded the Leadership Palm

Beach County's "Leadership Excellence" Award for 2009 (Class of 1998). Ms. Cheives (Class of 2002) was one of the finalists for this year's award. The Award is designed to recognize exceptional Leadership Program graduates who have made significant and notable contributions for the betterment of the community. ### IX. Old Business

CJC staff applied for a maximum grant totaling \$750,000 for a one year with a potential for continued funding for an additional two years contingent upon the availability of funds.

The Second Chance Act of 2007 (Pub. L. 110-199) provides a comprehensive response to the increasing number of people who are released from prison and jail and returning to communities. The Second Chance Act will help ensure the transition individuals make from prison or jail to the community is safe and successful. Section 101 of the Act authorizes grants to state and local governments and federally recognized Indian tribes that may be used for demonstration projects to promote the safe and successful reintegration into the community of individuals who have been incarcerated.
