- I. Chair Barbara Cheives called the meeting to order at approximately 8:05 a.m. Welcome was extended to members and guests.
- II. Roll call was taken and a quorum was present.
- III. Chair Cheives invited guests to introduce themselves.
- IV. The agenda was unanimously approved after amendment to present an update on the delinquency drug court by Judge Alvarez before proceeding with business items.
- V. The minutes of the January 24 meeting were unanimously approved.
- VI. Under Chairman's Comments, Chair Cheives informed members of the new Legislative Delegation appointee, Representative Mack Bernard who will officially be welcome on his first meeting attendance.
- VII. Under Executive Director's comments, Mr. Rodriguez advised that the Probation Advisory Board (PAB) met with a full quorum and approved the recommendations presented at the January CJC meeting.
- VIII. Under New Business, Executive Director Michael Rodriguez presented a proposed resolution by the Board of County Commissioners (BCC). The BCC sought CJC's support in enacting a ban on large capacity ammunition feeding devices (LCAFD) including magazine, belt, drum, feed strip, or similar device that has the capacity of, or can be readily restored or converted to accept more than 21 rounds of ammunition. This includes the transfer, possession or manufacturing of such devices in the State of Florida, except for law enforcement officers.

Members unanimously approve support of the BCC's decision on the resolution.

# X. CJC Initiatives/Updates

# A. Delinquency Drug Court

The mission of the Delinquency Drug Court is to reduce juvenile crime and drug use through therapeutic interventions, collaborative community partnerships and intensive judicial supervision of court-involved youth and families thereby improving juvenile and family functioning and community safety. The program started in 2008 and had a total admission of 40 kids. To date there are 12 graduates, and a total of 13 kids currently in the program.

In his presentation, Judge Alvarez commented on the program's success, noting that the recidivism rate for drug court graduates is 0%. The cost is just over \$4,000 per kid to be in the program and takes about nine months for successful completion. He said that while there is great collaboration of the various partners in the criminal justice system, there is still a need for others to be engaged and get involved. He commented on the importance of parent relationships for the success of the program and said he wished that there was greater participation in the program.

In conclusion, Judge Alvarez invited members and guests to the upcoming graduation scheduled for March 23, 2011.

### B. Juvenile Justice Referrals

Mr. Rodriguez presented a draft presentation which he said will be presented at the BCC at their March 15, 2011 meeting. The presentation highlighted the number of juveniles in the criminal justice system, youth referrals to the Department of Juvenile Justice (DJJ), DJJ's average daily population, demographics, number of youth direct filed, youth diversion from court, as well as comparisons among other counties in the State of Florida.

Mr. Rodriguez noted that there has been an overall significant downward trend in DJJ referrals despite an increase in youth population, a decrease in youth being direct filed in Palm Beach County even though higher when compared to other counties. The average number of youth in county jail has also been reduced by 15.6% since 2008.

Discussions surrounded the large number of youth being direct filed and the disproportionately high amounts of minority youth involved in juvenile justice and the criminal justice systems in the County.

Members expressed concerns to be addressed before presenting to the BCC.

# XI. Member Comments:

There were no member comments.

There being no further item for discussion, the business meeting was adjourned at approximately 8:50 a.m. before transitioning to the annual planning meeting.
