XI. CJC Initiatives/Updates

The following grants are currently being pursued by CJC staff:

- A. 2013 Byrne Criminal Justice Innovation grant in the amount of \$1M. This is for a neighborhood revitalization project that targets persistently distressed neighborhoods that have significant crime challenges.
- B. 2013 Adult Drug Court Discretionary Grant in the amount of \$200,000 to potentially target a gender specific drug court as part of the expansion of the program.
- C. Staff is also working with several partners to submit a YouthBuild Grant in the amount of \$1.1M to provide "disconnected youth" with a pathway to education and employment through the construction industry. Workforce Alliance will be the applicant.
