VII. Executive Director's Comment

- A. CJC was recently awarded an implementation grant for juvenile reentry. The competitive application was submitted on the heels of a two year planning phase. The funds will be focused on supportive housing, job training and placement, and completion of probation.
- B. The 25th Citizens Criminal Justice Academy received over 70 applications and close to 60 participants attended the first day. Classes continue each Monday through December 16, 2013, with the exception of November 11th (federal holiday) from 6:00 p.m. to 9:00 p.m.

- C. The community youth symposium held at the Palm Beach County Convention Center on Wednesday, September 25, 2013 was well attended. Participants included the Board of County Commissioners, the School Board, the Board of Children's Services Council as well as many other invitees.
- D. The Youth Empowerment Centers will be funded to the tune of \$420,000 from the Board of County Commissioners.
