- I. Chairman Richman called the meeting to order and extended a welcome to members and guests.
- II. Roll call was taken and a quorum was present.
- III. Chair Richman invited guests to introduce themselves.
- IV. The agenda for the October 22, 2018 meeting was unanimously approved after a motion by Mr. Joseph Ianno, Jr. and a second by Mr. Keith James.
- V. The Minutes of the September 24 meeting was unanimously approved after a motion by Mr. Randy Johnson and a second by Mr. Keith James.

#### VI. Chairman's Comments:

- A. Chair Richman announced that Mr. Damir Kukec, Manager of Research and Planning for the CJC would stand in for Executive Director Kristina Henson, who was not able to attend the meeting.
- B. Chair Richman announced the CJC February 25, 2019 meeting will be held in a different format, consisting of a 3-hour workshop focusing on the activities of the MacArthur Safety & Justice Challenge Grant.

### **VII. Executive Director Comments:**

A. Mr. Damir Kukec reminded the attendees that the 36<sup>th</sup> Citizen's Criminal Justice Academy is in session and will continue through December 17.

- B. Mr. Kukec announced the Community Engagement Task Force will host their next public event on October 25, 2018 in Boynton Beach.
- C. Mr. Kukec presented the new CJC Brochure from the Community Engagement Task Force on What To Do if Stopped by a Law Enforcement Officer.
- D. Mr. Kukec announced a workshop hosted by the Palm Beach County Community Services Department titled "Rethinking Poverty: Building Pathways to Economic Mobility", to be held on October 25, 2018 from 1:00 p.m. until 4:00 p.m.
- E. Mr. Kukec announced the Association of Prosecuting Attorneys (APA) is hosting a Leadership Conference in West Palm Beach November 29-30. The APA is a strategic ally in the MacArthur Safety & Justice Challenge, helping prosecutors accomplish grant goals.
- F. Mr. Kukec announced a Save the Date for Palm Beach County Race to Equity Summit 2, on February 20-21, 2019, in West Palm Beach.
- G. Mr. Kukec announced there are three spots the CJC has available for the 2019 Judge Marvin Mounts Prison Tour on March 27-28, 2019.

#### VIII. Old Business:

A. Chair Richman introduced Judge James Martz, Chair of the LEPC School Safety Committee, who gave a progress update. Judge Martz gave an overview of the Law Enforcement and Fire Rescue Trainer Symposium held on October 12, 2018. Judge Martz stated it was an important event because the discussions were very open and straightforward and allowed the various agencies to openly engage and discover where strengths and weaknesses lie and how to work together more efficiently. Notably among the various discussions was the deployment of law enforcement officers during an active shooter incident, the inherent risks and advantages to law enforcement officer self-deployment, and the coordination between law enforcement and fire rescue operations. Judge Martz said the next meeting on November 6 will focus on mental health and law enforcement professionals, how treatment modalities differ and how to streamline those processes.

#### IX. New Business:

A. Chair Richman presented Ms. Stephanie Sejnoha, Director of Public Safety, and Craig Spatara, Manager of Criminal Justice Programs, who gave an overview of the Public Safety Reentry Program and its activities in 2018. Ms. Sejnoha and Mr. Spatara presented a timeline of the changes and enhancements in the program, data and facts that support the important impacts the Reentry program has on the community. The Reentry Task Force

organizational chart, current recidivism rates, significant accomplishments and plans for the future were highlighted. A success story video of a client who is now employed by Palm Beach County was shown to illustrate the positive influence of the Reentry Program. Judge Kathleen Kroll advocated for the need to find more resources and programs for the Youth Reentry program. Judge James Martz addressed issues in preventing incarceration, and described the Upward Spiral program. He also addressed how to follow through on their post-commitment progress within 90 days to prevent re-incarceration. Mr. Gregory Starling commented on various programs sponsored by the Department of Juvenile Justice for transitioning youth and providing stability to improve outcomes.
