The four CJC seats were offered to School District Director of Support Services Elaine Hubbard-Williams; School District Student Advocacy Specialist Sandra Forbes-Edwards; Legislative Aide Amy Chamberlain; and Fifteenth Circuit Staff Attorney Supervisor Kelly Rowley. The Re-entry Simulation was held on Wednesday April 5, 2023 in Riviera Beach and over 100 participants and volunteers attended. This simulation was a great exercise demonstrating, as best possible, the challenges individuals released from the jail and prison systems encounter and endure.

- A. Approval of Proposed FY 2024 budget to include \$200k Supplemental Request for Reentry in the Glades (attached) Marianela Diaz & John Port, CJC Finance reps.
- B. Discussion to make application for BJA FY23 Community Courts Initiative grant in the amount of \$900,000 over 4-years (\$225,000/yr) with a 25% match requirement. Only five grants will be awarded. As an update, the CJC made a legislative appropriation request in the amount of \$367,420 to fund a Balanced Community Justice project, which would serve as an intervention community court model in the West Palm Beach and operated in partnership with the City of West Palm Beach Police Department. However, \$183,710 has been allocated from the House budget, which is pending the Governor's approval.

X. Director's Comments

- A. Attached is the grant application packet submitted on March 28, 2023 for the Justice and Mental Health Collaboration grant approved by the CJC and county administration to submit. This is a 3-year grant totaling \$550,000, of which \$100,000 is allocated for one-year planning and the balance is for implementation to create and, in some cases, enhance the systems and processes serving youth with mental health disorders (MHDs) or co-occurring mental health and substance use disorders (MHSUDs) who are at risk of, or who have, encountered the juvenile/criminal justice system.
- B. The MacArthur Foundation's Safety and Justice Challenge All-Sites Conference will be held May 3-5, 2023 in St. Louis, MO. PBC was awarded nine delegate slots, which will be filled as follows: CJC staff, 1) Regenia Herring, 2) Katherine Shover, 3) Dawn Davenport and 4) Margo Smith; 5) CJC Chair, Kevin Jones; 6) Latronda Hayes, Manager, Pretrial Services; 7) Dan Eisinger, Chief of Felony Div., Public Defender's Office; 8) Cheo Reid, Chief of Juvenile Div., State Attorney's Office; and 9) Jaime-Lee Bradshaw, Chief Strategist, Community Partnerships. Regenia and Jaime-Lee were invited to participate in an invitational only Community Engagement Pre-Conference meeting facilitated by Everyday Democracy. Additionally, Regenia will be a part of an in-person and live-streamed panel discussion titled "Your local Criminal Justice Coordinating Council: Becoming More Focused, Sustainable, and Representative of Your Local Community".
