

This Session the Legislature passed an \$88.7 billion budget, while cutting taxes by almost \$550 million. In addition, there were three local bills passed by our delegation and signed by Governor Scott.



For eight years, I have represented the citizens of Palm Beach County and it has been my honor to serve as Chair of the Delegation this past year. It is a privilege to be among those who advocate for Palm Beach County and Home Rule in the Legislature, and I am very proud to work with my colleagues on behalf of Palm Beach County's residents.

Executive Director's Report



I have enjoyed working closely with the members and staff of the delegation this year as Executive Director of the Palm Beach County Legislative Delegation.

We have composed this report to give you a comprehensive overview of the priority issues the delegation has worked on during the 2018 legislative session. You will also find a detailed list of appropriations that the legislature allocated to Palm Beach County, as well as those vetoed by the Governor. Our delegation members worked countless hours to bring these appropriations home.

These hours consisted of individual meetings with constituents and groups, numerous public hearings throughout the County (including joint workshops with

the Palm Beach County League of Cities, School Board and Board of County Commissioners), several weeks of committee hearings, and the annual 60-day Legislative Session in Tallahassee.

I would like to thank the delegation members and especially the delegation staff for their tireless work this Session. They are the hardest working people I have met and the successes this session reflects all their efforts. Kudos on a job well done! I would also like to thank our legislative delegation aide, Rachel Zara. She does a great job of keeping the Delegation office running smoothly and supporting our efforts while we are in Tallahassee.

Finally, I want to thank our Delegation Chair, Representative Bill Hager, for his leadership over the past year and for his advocacy for Palm Beach County over the past eight years in the House. You will be missed as member of our Delegation. It has been an absolute honor and privilege working with you.

2018 Legislative Session Summary

February 14, 2018 marked a day of great sadness in Florida when 17 people were killed and 17 others were injured in a mass shooting at Marjory Stoneman Douglas High School in the City of Parkland. In response to the tragedy, the Legislature passed SB 7026 - the Marjory Stoneman Douglas High School Public Safety Act. This legislation provides law enforcement, courts, and schools with the tools to enhance public safety by temporarily restricting firearm possession by a person undergoing a mental health crisis and when there is evidence of a threat of violence. The bill appropriates \$200 million in nonrecurring and \$200 million in recurring funds to put those requirements in place. Among its many provisions, the bill prohibits a person under 21 years of age from purchasing a firearm; requires a three-day waiting period for all firearms, not just handguns; and bans the sale of bump stocks.

The House and Senate, along with Governor Scott, continued to look at ways to curb the growing opioid epidemic in the state. One of the bills signed into law by Governor Scott, HB 21 - Controlled Substances, will expand the use of the Prescription Drug Monitoring Program requiring healthcare providers prescribing controlled substances to run the patient's history through the Program. HB 21 also limits prescriptions for Schedule II opioids to a 3-day supply, or a 7-day supply if deemed medically necessary. That provision excludes pain related to cancer, terminal illness, palliative care, and serious traumatic injury from these prescribing limits. The bill amends and strengthens criminal laws, and provides over \$53 million in appropriations for state agencies, emergency responders, and other entities to aid in prevention, treatment, and recovery activities.

After Hurricane Irma, nursing homes and assisted living facilities came under scrutiny when 12 residents died in a nursing home due to excessive heat following the massive storm. The legislature passed new legislation requiring that nursing homes and facilities have generators and fuel on hand for 72 hours. Appropriations were included in the budget to address the ongoing hurricane recovery efforts with more than \$40 million allocated for agricultural storm damage, \$90 million for federal disaster recovery grants for communities, \$126 million in assistance for students displaced by Hurricane Maria from Puerto Rico and the U.S. Virgin Islands, and \$11.2 million for beach repairs.

2018 Local Bills

HB 889 - West Palm Beach Police Pension Fund of the City of West Palm Beach

This bill amends the special act for the West Palm Beach Police Pension Fund, established in 1947. The bill revises retirement pension calculations for the City of West Palm Beach police department and corrects scrivener's errors. The bill also makes two clarifying changes concerning the effective date of a previous change to the special act and a reference to Deferred Retirement Option Plan (DROP) account balances for deceased fund members.

Signed by the Governor on March 23, 2018; Chapter No. 2018-168.

HB 901 - Acme Improvement District and Pine Tree Water Control District **Rep. Matt Willhite**

This bill transfers the portion of the Flying Cow Ranch property within the Acme Improvement District and places it in the jurisdiction of the Pine Tree Water Control District to facilitate the development of the Flying Cow Ranch property. Currently, 50 acres of the property lies within Acme Improvement District and 100 acres lies within the Pine Tree Water Control District. The bill also amends the charters of the Acme Improvement District and the Pine Tree Water Control District to state the new boundaries of each District as a result of the parcel move.

Signed by the Governor on March 23, 2018; Chapter No. 2018-170.

HB 1093 - Loxahatchee Groves Water Control District

This bill dissolves the Loxahatchee Groves Water Control District as an independent special district and transfers it to the Town of Loxahatchee Groves as a dependent special district. The bill repeals all special acts of the Loxahatchee Groves Water Control District and all provisions will become ordinances of the Town of Loxahatchee Groves. The bill will take effect only upon its approval by a majority of those landowners of the District voting in the same manner by which the District's governing body is elected in a referendum to be held no later than October 1, 2018.

Signed by the Governor on March 23, 2018; Chapter No. 2018-175.

HB 1113 - Palm Beach County Housing Authority

This bill would have allowed the governing body of Palm Beach County to appoint two additional members to the Palm Beach County Housing Authority. The Palm Beach County Housing Authority is a five-member board appointed by the Governor. The bill would have expanded the governing board of the Palm Beach County Housing Authority from five members to seven members. The members appointed would have been qualified electors of the county and subject to removal or suspension by the governing body of the county.

Vetoed by the Governor on March 30, 2018.

Legislation Sponsored by Delegation Members

SB 4 - Higher Education

This bill, the Florida Excellence in Higher Education Act of 2018, was a priority of **Senate President Joe Negron**. It reinstates full funding of the Bright Futures Florida Academic Scholars Award at 100 percent of tuition and fees for spring, summer, and fall semesters; plus \$300 in fall and spring semesters to cover instructional materials and other costs. The bill also funds the Bright Futures Florida Medallion Scholars Award at 75 percent of tuition and fees beginning in the fall semester of the 2018-2019 academic year. Additionally, the bill expands and enhances policy and funding tools, allowing Florida's universities to recruit and retain the very best faculty, together with providing the resources necessary to increase the ability for the universities to compete as national destination institutions.

Signed by the Governor on March 11, 2018; Chapter No. 2018-4.

HB 33 - Texting While Driving prime cosponsored

This bill would have amended the Florida Ban on Texting While Driving law to change the current enforcement of the ban on texting while driving from secondary to primary. The change would have allowed a law enforcement officer to stop a vehicle solely for texting while driving. Additionally, the bill would have required a law enforcement officer who detains a motor vehicle operator for texting while driving to inform the operator that he or she has a right to decline a search of their cellphone. Lastly, the bill would have required a law enforcement officer to record the race and ethnicity of a person issued a citation for texting while driving.

Died in Senate Communications, Energy, and Public Utilities Committee.

HB 61 - Restoration of Civil Rights

This bill would have restored civils rights to former felons after the sentence of incarceration and community supervision. The bill would have focused on civil rights such as voting, but would not have authorized former felons to own, possess, or use firearms.

Died in House Criminal Justice Subcommittee.

HB 155 - State Symbols

This bill removes the repeal of the Loggerhead Turtle as the official state saltwater reptile and the Florida Cracker Horse as the official state horse both scheduled to repeal on July 1, 2018. In 2008, the Legislature designated the Loggerhead Turtle as the official state saltwater reptile and the Florida Cracker Horse as the official state horse. These animals will now remain the designated state symbols. Additionally, the bill designates the Florida Cracker Cattle as the official state heritage cattle breed.

Signed by the Governor on March 21, 2018; Chapter No. 2018-43.

HB 217 - Payment of Health Care Claims

This bill would have prevented health insurance companies from retroactively denying a service they had previously authorized. Physicians must obtain pre-approval from insurers, in order to provide certain care for their patients. However, there are times when patients have had a procedure pre-approved and after the procedure, the insurance company will retroactively deny the claim and refuse to pay. This bill would have guaranteed that an insurance company could no longer deny previously approved claims leaving physicians or the patients uncovered.

HB 227 - Workers' Compensation Benefits for First Responders

This bill provides first responders with wage replacement benefits for a mental or nervous injury following a diagnosis of job related post-traumatic stress disorder (PTSD). The bill allows first responders to receive proper medical treatment regardless of whether the individual's PTSD is accompanied by a physical injury requiring medical treatment to ensure they are in the best physical and mental shape to continue to serve their communities. The bill also requires an employing agency of a first responder to provide educational training related to mental health awareness, prevention, mitigation, and treatment.

Passed as SB 376 (Book) and signed by the Governor on March 27, 2018; Chapter No. 2018-124.

HB 231 - Risk Protection Orders

Although this bill died in the House Criminal Justice Subcommittee, a large portion of the bill's language was incorporated in the final version of SB 7026 - Marjory Stoneman Douglas High School Public Safety Act. HB 231 was modeled after similar legislation already in existence in California, Washington, Oregon, Connecticut, and Indiana. Those states allow law enforcement to petition a court to remove firearms and prohibit the purchase of firearms from an individual who is a danger or threat to themselves or others.

Incorporated into SB 7026 and signed by the Governor on March 9, 2018; Chapter 2018-3.

SB 318 - Internship Tax Credit Program

This bill would have created the "Florida Internship Tax Credit Program" which would have authorized a corporate income tax credit up to a specified amount to a qualified business paying wages to a degree-seeking student during the student's internship at the business.

Died in Senate Education Committee.

HB 393 - Discrimination in Labor and Employment

This bill would have created the "Helen Gordon Davis Fair Pay Protection Act" in honor of Helen Gordon Davis for her hard work in the field of equal pay. The bill hoped to strengthen state laws in this arena. Provisions in the legislation would have included prohibiting employers from providing less favorable employment to employees based on sex, failing to notify an employee about other careers tracks and promotion opportunities, and prohibiting an employer from requiring salary history of applicants.

Died in House Careers & Competition Subcommittee.

HB 421 - Homestead Waivers

This bill creates safe harbor language that may be placed in a deed, indicating that a spouse is waiving his or her rights in a homestead property. The bill clarifies that a spouse's waiver of certain limitations on homestead transfer can be included in a recorded deed.

Passed as SB 512 (Young) and signed by the Governor on March 19, 2018; Chapter No. 2018-22.

HB 443 - Nursing Home and Assisted Living Facility Resident Rights

This bill would have required nursing homes and assisted living facilities to notify residents and the State Long Term Care Ombudsman of the facility's current contact information, including a functional telephone number, and of any change in contact information within 30 days after such change. The bill would have required an assisted living facility to provide residents with 45 days' written notice of relocation or termination of residency and required an assisted living facility that is relocating a resident to provide the reasons for relocation to the resident or the resident's legal representative. Lastly, the bill would have required that an assisted living facility's location information is current and reported to the Agency for Health Care Administration for posting on its consumer information website.

HB 491 - Theft

This bill increases the mandatory fine to \$10,000 for theft of commercially farmed animals or bee colonies of a registered beekeeper.

Signed by the Governor on March 21, 2018; Chapter No. 2018-49.

HB 577 - High School Graduation Requirements

This bill allows a student to use credit earned upon completion of a Department of Education registered apprenticeship or pre-apprenticeship program to satisfy the credit requirements for fine or performing arts, speech and debate, or practical arts to graduate. The bill also requires the State Board of Education to approve and identify in the Course Code Directory apprenticeship and pre-apprenticeship programs from which a student may use earned credit to satisfy graduation requirements.

Signed by the Governor on April 6, 2018; Chapter No. 2018-154.

SB 582 - Write-in Candidate Qualifying

This bill codifies the 2016 Florida Supreme Court decision in Brinkmann v. Francois by repealing the statute that requires a write-in candidate to reside in the district that he or she seeks to represent at the time of qualifying. The Florida Constitution sets forth residency requirements for legislators, county commissioners, justices and judges, the governor, lieutenant governor, and members of the cabinet. The constitutional residency requirement for legislators, county commissioners, justices and judges has been interpreted by Florida courts to mean that residency within the district represented by the office sought is required at the time of election or at the time the candidate assumes office. Current law, s. 99.0615, F.S., requires a write-in candidate to reside within the district represented by the office sought at the time of qualification. The Florida Supreme Court recently found the statute unconstitutional because it conflicts with the residency requirements within the Florida Constitution.

Passed as HB 6009 (Geller) and signed by the Governor on March 30, 2018; Chapter No. 2018-141.

HB 635 - Victim Assistance

This bill would have required a law enforcement agency to provide information to victims if their property is located in a pawnshop. The bill was introduced with the objective of returning property back to victims and stated that the victim's property shall be returned promptly unless there is a compelling law enforcement reason for retaining it.

Died in House Criminal Justice Subcommittee.

HB 637 - Fire Safety and Prevention/SB 820 - Firesafety Inspectors Rep. Al Jacquet/Sen. Bobby Powell

This bill would have created s.633.217, F.S., and prohibited certain actions to influence a firesafety inspector by coercion or compensation to violate the Florida Fire Prevention Code. The bill would have imposed criminal penalties for violation of the prohibited provisions including persuading, coercing, threatening, tricking, and any other form of interference. A first offense would be a second-degree misdemeanor. A second or subsequent offense would have constituted a first-degree misdemeanor.

HB 637 died in House Criminal Justice Subcommittee and SB 820 died in House Messages.

HB 673 - Reporting of Adverse Incidents in Planned Out-of-Hospital Births Rep. MaryLynn Magar

This bill requires a physician, certified nurse midwife, or licensed midwife attending a planned out-of-hospital birth to submit an adverse incident report to the Department of Health, within 15 days of the occurrence of the incident. The bill defines an adverse incident as an event over which the physician, certified nurse midwife, or licensed midwife could exercise control and one of the following occurs:

- maternal death that occurs after delivery or within 42 days after delivery;
- maternal patient is transferred to a hospital intensive care unit;
- maternal patient experiences hemorrhagic shock or requires a transfusion of more than four units of blood or blood products;
- fetal or newborn death, including a still birth, attributable to an obstetrical delivery;
- newborn patient is transferred to a hospital neonatal intensive care unit (NICU) due to a traumatic birth injury;
- newborn patient is transferred to a hospital NICU within 72 hours after birth if the newborn remains in the NICU for more than 72 hours or;
- any other injury as determined by department rules.

The bill also requires the attending health care practitioner to provide a medical summary of the events in the adverse incident report. The Department of Health must review each adverse incident report to determine whether the incident involves conduct for which the health care practitioner may be subject to disciplinary action and authorizes the Department of Health to adopt rules to implement the provisions of the bill.

Passed as SB 510 (Young) and signed by the Governor on March 19, 2018; Chapter No. 2018-21.

HB 721 - Mental Health

This bill would have required county jails to continue to administer prescribed psychiatric medications upon the individual's return to jail after receiving care at a mental health facility unless the jail physician documents the need to change or discontinue such medication. This is essential to maintain the stability of the inmate's mental health throughout the duration of their court case. Additionally, the bill would have required county jails to send all medical information for individuals in their custody who will be admitted to state mental health treatment facilities. This bill will be introduced again in 2019.

Died in House Returning Messages.

HB 813 - Licensure of Unarmed Security Guards

This bill would have allowed applicants for a Class "D" unarmed security officer license to take training classes online. Applicants obtaining a license to become an unarmed security guard would no longer be required to complete their training at a brick and mortar facility. The bill would have also allowed school and training facilities to offer such training courses online.

Died on House Second Reading Calendar.

SB 936 - Juvenile Justice

This bill would have eliminated mandatory direct file of a child and changed the discretionary prosecution of children as adults. The bill would have revised the list of crimes for which children of specified ages who are charged with committing, attempting to commit, or conspiring to commit may be transferred to adult court by a state attorney. The bill also would have required the Department of Corrections to make every reasonable effort to ensure that any child between the ages of 16 and 18 years old who is convicted and sentenced be completely separated from adult offenders in the facility.

Died in Appropriations Subcommittee on Criminal and Civil Justice.

This bill addresses clean-up issues for the Department of Financial Services, eases regulatory burdens for licenses overseen by the department, and modernizes technology. For our youth aging out of foster care, there is now a requirement that the Department of Financial Services provide information on financial literacy and requires young adults who have aged out of foster care who request aftercare services to receive this information. The bill also provides consumer protection by barring individuals who were directors or officers of bankrupt insurers from serving in that capacity again. It also adds arson involved insurance fraud to the list of crimes that a reward can be offered for when the tip leads to an arrest.

Signed by the Governor on March 23, 2018; Chapter No. 2018-102.

HB 1099 - Advanced Birth Centers

This bill would have created a new licensure program within the Agency for Health Care Administration for advanced birth centers. An advanced birth center is a birth center that may perform trial of labor after cesarean deliveries for screened patients that qualify, planned low risk cesarean deliveries, and anticipated vaginal delivery of laboring patients at the beginning of the 37th week of gestation to the end of the 41st week of gestation. The bill would have required advanced birth centers to be operated and staffed 24 hours per day, 7 days per week. The bill also would have required a mother and her infant to be discharged from the advanced birth center within 48 hours after the birth of the infant for a vaginal delivery and within 72 hours when delivery is by cesarean section, except in unusual circumstances as defined by rule.

Died in House Health & Human Services Committee.

HB 1147 - Abandoned Animals

This bill was filed in response to the 2016 animal cruelty case, State v. Milewski, during which the trial court held that Mr. Milewski had an expectation of privacy in the remains of his dead beagle puppy, Molly. The opinion of the trial court was overturned on appeal. This bill would have specified that an animal owner who abandons the animal has no expectation of privacy in the animal's body or remains.

Died in House Agriculture & Property Rights Subcommittee.

HB 1211/SB 1612 - Airboat Regulation

This bill creates "Ellie's Law" in honor of Elizabeth "Ellie" Goldenberg who died in 2017 from injuries she sustained after being thrown from an airboat on an Everglades airboat tour. The bill establishes minimum safety certification standards for commercial airboat operators carrying passengers for hire on state waters. Operators must now complete a boating safety course or have a coastguard captain's license, complete a Fish and Wildlife Conservation Commission approved airboat course and be CPR certified. A person who violates the airboat operating provisions commits a misdemeanor of the second degree, punishable by up to 60 days imprisonment or a \$500 fine.

Passed as HB 1211 and signed by the Governor on March 30, 2018; Chapter No. 2018-137.

HB 1335 - Capitol Relocation Task Force

This bill would have created a task force with members appointed by the Legislature, the Governor, and the State Employee Unions. It would have considered the fiscal impact of relocating the state capitol building and the Legislative and Cabinet offices. In addition, the task force would have taken into consideration the cost involved in traveling to Tallahassee compared to a part of the state more accessible to the most residents as well as the time involved in travel and accessibility to Floridians.

Died in House Oversight, Transparency & Administration Subcommittee.

SB 1364 - Public Records/Substance Abuse Service Providers

This bill creates an exemption to protect certain personal identifying information of mental health and substance abuse treatment facility professionals, their spouses, and children. The bill provides staff protection from the danger of physical and emotional harm from hostile patients who may react inappropriately and violently to actions taken of the employees.

Passed as HB 1055 (DuBose) and signed by the Governor on March 21, 2018; Chapter No. 2018-64.

SB 1392 - Criminal Justice

A priority of **Senate President Joe Negron**, this bill requires the creation of a pre-arrest diversion program in each judicial circuit. Among other requirements, each judicial circuit's pre-arrest and civil citation or similar pre-arrest diversion program must specify the misdemeanor offenses that qualify an offender for participation in the program as well as the program's requirements, including, but not limited to: the completion of community service hours; payment of restitution, if applicable; and intervention services indicated by a needs assessment of the offender. Additionally, the bill requires the Florida Department of Law Enforcement to adopt rules to provide for the expunction of a non-judicial record of the arrest of a juvenile who has successfully completed a diversion program for a misdemeanor offense.

Signed by the Governor on March 30, 2018; Chapter No. 2018-127.

HB 1437 - Employment Services for Persons with Disabilities

This bill extends state workers' compensation benefits to participants of work experience programs within the Division of Blind Services and Vocational Rehabilitation. Extending these, benefits will maximize employment opportunities for persons with disabilities and increase their independence and self-sufficiency, while reducing costs for employers.

Signed by the Governor on March 21, 2018; Chapter No. 2018-72.

SB 1440 - Mental Illness Training for Law Enforcement Officers

The bill would have required the Florida Department of Law Enforcement to establish a continued employment training component relating to mental illness. The training would have focused on the recognition of symptoms and characteristics of an individual with a mental illness and appropriate responses to an individual exhibiting such symptoms and characteristics. Completion of the training component would have counted toward the 40 hours of instruction for continued employment or appointment as a law enforcement officer.

Died in Senate Appropriations.

HB 1441 - Minimum Wage

This bill would have increased the minimum wage through a periodic increase per year to meet the cost of inflation. The yearly increase would have been calculated by the Consumer Price Index for Urban Wage Earners and Clerical Workers for the cost of inflation. Additionally, the bill would have proposed adding \$1 to the cost of inflation for the first year, and \$1.50 every additional year.

Died in House Careers & Competition Subcommittee.

SB 1790/HB 1377 - Baker Act

This bill would have directed the Department of Children and Families (DCF) to create a workgroup to evaluate methods to improve the operational effectiveness of the Florida Mental Health Act and recommended changes to existing laws, rules, and agency policies needed to implement the workgroup recommendations. The bill would have identified the members of the workgroup and a final report would have been provided to the Secretary of DCF, the Secretary of the Agency for Health Care Administration, the President of the Senate, and the Speaker of the House of Representatives with the workgroup's findings and recommended statutory and administrative rule changes by November 1, 2018.

SB 1790 died in Senate Appropriations and HB 1377 died in House Children, Families & Seniors Subcommittee.
