After four months of committee meetings, where members filed numerous bills and budget requests, the 2020 legislative Session got underway on January 14, 2020. The first day of the session was marked with the Governor's State of the State address and the ceremonial convening of the legislative session. Committee meetings are ongoing with appropriation subcommittees continuing to hear budget requests in the House and the Senate will be hearing policy legislation.

Over 250 Elected officials, education partners, community and business leaders traveled to Tallahassee to meet with legislators advocating for the shared priorities of the County. Bills and Policy

On Monday, Representatives Caruso, Jacquet, Polsky, Roth, Silvers and Willhite all had appropriations bills heard in subcommittees that passed favorably and are now waiting for the appropriations process to begin. Page 3

On Tuesday, SB 878-Public Records/Emergency Room Health Care Practitioners, SB 544 Husband-Wife Communications Privilege and SB 500 Prohibited Acts by Health Care Practitioners by Senator Harrell passed favorably out of their first committee and are now moving into their second committee.

SB 1296 Health Access Dental Licenses by Senator Berman also passed favorably out of its first committee.

During Wednesday's Health Care Appropriations Subcommittee, Rep. Willhite's two bills passed favorably, HB 57 Dispensing Medicinal Drugs and HB 59 Automated Pharmacy Systems and are moving on to Health & Human Services Committee, their final stop before heading to the House floor for final passage. HB 919 Property Tax Exemptions Used by Hospitals by Rep. Caruso was heard in its first subcommittee, Health Market Reform, having passed favorably it is now on to its next committee stop, Ways and Means.

The week culminated on Thursday with HB 945 Children's Mental Health by Rep. Silvers being passed favorably in the Children, Families & Seniors Subcommittee. It is now on to its second committee stop, Health Care Appropriations Subcommittee. HB 61 Adoption Benefits by Rep. Roth was also heard in Health Care Appropriations Subcommittee, after passing favorably it is now on to its last stop before heading to the House floor for final passage.

Although only a handful of bills by Delegation members were heard this week, our Delegation members have filed a combined total of 171 House and Senate bills, local bills and resolutions. Each member is dedicated to passing legislation that will not only benefit their district constituents but also Palm Beach County and Florida residents.

Local Bills

The Palm Beach County Legislative Delegation members have three local bills this legislative session:

- HB 975 Indian Trail Improvement District, Palm Beach County by Rep. Roth,
- HB 753 Town of Lake Clarke Shores, Palm Beach County by Rep. Silvers
- HB 673 Port of Palm Beach District, Palm Beach County by Rep. Willhite.

Each of these local bills was heard on October 3rd, 2019 at the Delegation local bill hearing and were passed unanimously for submission to the legislature for action. They are all now awaiting a hearing in their first committee, Local Administration Subcommittee.

Member Highlights

This week Rep. Caruso was proud to sponsor Alexa Concannon to the House of Representatives Page and Messenger program. This historic program provides the opportunity for students to observe state government in action during the 60-day regular legislative session.



Appropriations

This week was a busy week for appropriations, 20 of our delegation were member bills heard. These delegation sponsored appropriation requests have passed favorably out of their subcommittees and are now waiting for the appropriations process to begin. Our Delegation House members have filed over 90 budget requests to bring home much-needed dollars for programs and projects throughout Palm Beach County. Our delegation Senate members have filed matching requests but the process in the Senate does not require actual bills to be filed and heard in committees.


