

KNOW ALL MEN BY THESE PRESENTS THAT THE TRUSTEES OF ADVENT LUTHERAN CHURCH, INC., A NOT FOR PROFIT CORPORATION, OWNER OF THE LAND SHOWN HEREON AS ADVENT LUTHERAN CHURCH, BEING A REPLAT OF A PORTION OF BLOCKS 2, 3, 4 AND 14, TOGETHER WITH A PORTION OF BAKER AVENUE (N.E. 4TH AVENUE), VILLA RICA, ACCORDING TO THE PLAT THEREOF, AS RECORDED IN PLAT BOOK 14, PAGES 73 THROUGH 82 OF THE PUBLIC RECORDS OF PALM BEACH COUNTY FLORIDA, LYING IN SECTION 8 TOWNSHIP 47 SOUTH RANGE 43 EAST, CITY OF BOCA RATON, PALM BEACH COUNTY. FLORIDA, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTHWEST CORNER OF LOT 12 OF SAID BLOCK 14, SAID POINT BEING ON THE EASTERLY RIGHT-OF-WAY LINE OF DIXIE HIGHWAY AS SHOWN ON SAID PLAT: THENCE S81°53'17"E ALONG THE SOUTH LINE OF SAID LOT 12, A DISTANCE OF 130,00 FEET; THENCE NO8'06'43"E, A DISTANCE OF 21.48 FEET TO A POINT OF INTERSECTION WITH THE WESTERLY PROLONGATION OF THE SOUTH LINE OF LOT 27 OF SAID BLOCK 14 THENCE S81'53'17"E ALONG SAID LINE, A DISTANCE OF 130.00 FEET TO THE SOUTHEAST CORNER OF SAID LOT 27, AND THE WESTERLY RIGHT-OF-WAY LINE OF BAKER AVENUE (N.E. 4TH AVENUE), AS SHOWN ON SAID PLAT: THENCE NO8'06'43"E ALONG SAID WESTERLY RIGHT-OF-WAY. A DISTANCE OF 662.43 FEET TO A POINT OF INTERSECTION WITH THE WESTERLY PROLONGATION OF THE SOUTH LINE OF SAID BLOCK 4; THENCE N89"23'23"E ALONG SAID LINE, A DISTANCE OF 290.06 FEET TO THE SOUTHEAST CORNER OF SAID LOT 7, BLOCK 4, AND THE WESTERLY RIGHT-OF-WAY LINE OF PRINDIVILLE AVENUE (N.E. 5TH AVENUE), AS SHOWN ON SAID PLAT: THENCE NOO"35"05"W ALONG SAID RIGHT-OF-WAY LINE, A DISTANCE OF 473.87 FEET; THENCE N45'26'25"W, A DISTANCE OF 35.27 FEET TO A POINT OF INTERSECTION WITH THE SOUTHERLY RIGHT-OF-WAY LINE OF YAMATO ROAD (STATE ROAD 794), AS SHOWN ON FLORIDA DEPARTMENT OF TRANSPORTATION RIGHT-OF-WAY MAP SECTION 93005-2502; THENCE S89"42'15"W ALONG SAID RIGHT-OF-WAY LINE, A DISTANCE OF 165.90 FEET TO A POINT OF CURVE TO THE LEFT HAVING A RADIUS OF 1.849.86 FEET AND A CENTRAL ANGLE OF 0818'31"; THENCE WESTERLY ALONG THE ARC OF SAID RIGHT-OF-WAY LINE A DISTANCE OF 268.25 FEET; THENCE S49'36'46"W, A DISTANCE OF 31.63 FEET TO A POINT OF INTERSECTION WITH THE EASTERLY RIGHT-OF-WAY LINE OF SAID DIXIE HIGHWAY; THENCE SO8'06'43"W ALONG SAID RIGHT-OF-WAY LINE, A DISTANCE OF 1,111.02 FEET TO THE POINT OF BEGINNING.

CONTAINING 424,643 SQUARE FEET OR 9.748 ACRES, MORE OR LESS. AND DO HEREBY DEDICATE AS FOLLOWS:

1. UTILITY EASEMENTS: THE UTILITY EASEMENTS, AS SHOWN HEREON, ARE HEREBY DEDICATED IN PERPETUITY TO THE CITY OF BOCA RATON FOR THE INSTALLATION, CONSTRUCTION. RECONSTRUCTION, OPERATION, MAINTENANCE, AND REPAIR OF WATER, SEWER, AND DRAINAGE, TRAFFIC CONTROL, AND OTHER FACILITIES OF THE CITY, FACILITIES OF PUBLIC UTILITIES OPERATING PURSUANT TO A FRANCHISE OR OTHER GRANT OF APPROVAL FROM THE CITY, AND ANY AND ALL OTHER USES AUTHORIZED BY THE CITY TOGETHER WITH APPURTENANCES OVER, THROUGH AND ACROSS SAID EASEMENTS. ALL PLATTED UTILITY EASEMENTS SHALL PROVIDE THAT SUCH EASEMENTS SHALL ALSO BE EASEMENTS FOR THE CONSTRUCTION, INSTALLATION, MAINTENANCE, AND OPERATION OF CABLE TELEVISION SERVICES; PROVIDED, HOWEVER, NO SUCH CONSTRUCTION, INSTALLATION, MAINTENANCE AND OPERATION OF CABLE TELEVISION SERVICES SHALL INTERFERE WITH THE FACILITIES AND SERVICES OF AN ELECTRIC, TELEPHONE, GAS OR OTHER PUBLIC UTILITY. IN THE EVENT A CABLE TELEVISION COMPANY DAMAGES THE FACILITIES OF A PUBLIC UTILITY, IT SHALL BE SOLELY RESPONSIBLE FOR THE DAMAGES. THIS SECTION SHALL NOT APPLY TO THOSE PRIVATE EASEMENTS GRANTED TO OR OBTAINED BY A PARTICULAR ELECTRIC, TELEPHONE, GAS OR OTHER PUBLIC UTILITY. SUCH INSTALLATION, MAINTENANCE AND OPERATION SHALL COMPLY WITH THE NATIONAL ELECTRICAL SAFETY CODE AS ADOPTED BY THE FLORIDA PUBLIC SERVICE COMMISSION.

2. ADDITIONAL RIGHT-OF-WAY TRACT RW, AS SHOWN HEREON IS HEREBY DEDICATED TO THE BOWN OF THE COMMISSIONERS OF THE CITY OF BOCA RATON, FLORIDA, FOR THE PERPETUAL USE OF THE PUBLIC FOR PUBLIC STREET PURPOSES.


