NO CONSTRUCTION, BUILDINGS, SIGNS, MONUMENTS OR ANY KIND OF LANDSCAPING SHALL BE PLACED IN SAID EASEMENTS WITHOUT THE PRIOR WRITTEN APPROVAL FROM THE VILLAGE OF TEQUESTA.

THE FPL EASEMENTS, AS SHOWN HEREON, ARE HEREBY DEDICATED IN PERPETUITY TO FLORIDA POWER AND LIGHT COMPANY (FPL), ITS SUCCESSORS AND ASSIGNS FOR THE INSTALLATION, MAINTENANCE AND OPERATION OF ELECTRICAL SERVICES AND OTHER UTILITIES INCLUDING BUT NOT LIMITED TO CABLE TELEVISION AND TELECOMMUNICATIONS SERVICES.


