

KNOW ALL MEN BY THESE PRESENTS, that G. A. Perkins and Lula Perkins, his wife, owners of the tract of land shown hereon and more particularly described as follows:-

Commencing at the Southeast corner of Sec. 2, Twp. 44 S., Rge. 35 E.; thence North, along the East line of said Sec. 2, a distance of 3360 feet to the point of beginning; thence North, along the East line of said Sec. 2, a distance of 350 feet to a point; thence West a distance of 625 feet, more or less, to a point on the East bank of the Miami Canal; thence Southerly, along the East bank of said Miami Canal, a distance of 350 feet, more or less, to a point; thence East a distance of 625 feet, more or less, to the point of beginning; have caused the same to be surveyed, subdivided, and platted as shown, and do hereby dedicate the alley, streets and road shown hereon to the perpetual use of the public, as public highways, and do hereby further dedicate, to the perpetual use of the public, the canal right-of-ways as shown hereon, reserving, however, unto themselves, their heirs or assigns the reversion or reversions of same whenever abandoned by the public or discontinued by law.


