



KNOW ALL MEN BY THESE PRESENTS that A. R. ROEDUCK, and his wife, MYRTLE P. ROEDUCK, the Owners in fee simple of the land lying and being in Palm Beach County, Florida, shown on the attached plat as SUBDIVISION OF SECTION 11, and more particularly described as follows:

All of Section 11, Township 43 South, Range 42 East, Palm Beach County, Florida, except the following described parcel of land: Beginning at a point on the north line of Section 11, Township 43 South, Range 42 East, said point being 1320 feet east of the northeast corner of said Section 11; thence east along said north section line of said Section 11, 1320 feet to the northeast corner thereof; thence south along the east line of said Section 11, 660 feet to a point; thence in a northeasterly direction 1676.26 feet to the place of beginning, containing 10 acres more or less.

Have caused the same to be surveyed and plotted as shown hereon, and do hereby dedicate to the perpetual use of the public the roadways as shown hereon, reserving however, unto themselves, their heirs, successors, assigns, or legal representatives, the reversion or reversions thereof, whenever the same shall be abandoned by the public or discontinued by law.
