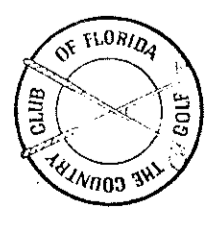

SUBJECT: APPROVAL OF WATER, SEWER AND CONSTRUCTION PLANS
AT DELRAY DUNES AND QUAIL RIDGE DEVELOPMENT BY
THE VILLAGE OF GOLF.

Dear Mr. Crosby:

Pursuant to our telephone discussion on April 16, 1973, the Village of Golf requests that all water, sewer and construction plans requiring approval by Palm Beach County for installations at Delray Dunes and Quail Ridge Developments be considered for such approval only after they have been approved and certified by a duly authorized representative of the Village of Golf. The reason for this request is that the water and sewer system owned and operated by the Village of Golf, in addition to serving the corporate limits of the Village of Golf, also serves the Delray Dunes and Quail Ridge developments, both of which are situated outside corporate limits in Palm Beach County. There is no current procedure to ensure that plans for water and sewer installations in these developments outside our corporate limits meet our requirements. As a consequence, additions to our water and sewer systems at housing starts have caused problems for both the Village and County, problems which could have been avoided if we had first approval of their plans.

Please advise us of the feasibility of co-operating with us in this regard. The duly authorized representative of the Village of Golf is M. M. Cantar, The Village Manager and Utilities Director, as certified by the signature of the Mayor below. If the Village of Golf is unable to fix a suitable approval stamp to such plans certified by the Utilities Director.

SUBJECT: Delray Dunes.

The subject development has been approved by the Florida State Board of Health under SC-88-16370. With the proviso that there is to be no occupancy until connection to the sewage collection system is complete. Consequently, this office will not require submission of dwelling units for approval. We do, however, want to advise by letter that any occupancy on public buildings such as the recreation pavilion, clubhouse, laboratories, etc.
