

the Southwest Quarter (SW 1/4) of Section 17, Township 44, South, Range 43, East, shown here on as
Plat No 4 of LAKE CLARKE GARDENS and more particularly described as follows, to wit:
Commencing at the 1/4 corner in the South line of said Section 17, thence on an assumed
bearing of due west, along the South line of said Section 17, a distance of 585.15 feet to the Point
of Beginning; thence continue due West, a distance of 1107.85 feet to the Southwest corner
of the Southeast Quarter of the Southwest Quarter of the Southwest Quarter of said
Section 17; thence N. 0° 19' 53" W, along the West line thereof, a distance of 277.25' to the
Northwest corner thereof; thence S. 89° 58' 30" E, along the North line thereof, a distance of
665.21 feet to the West line of the Southeast Quarter of the Southwest Quarter of said Section
