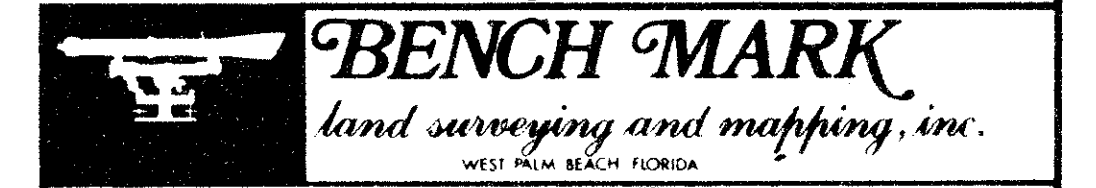


-KEY MAP-
