



The streets shown hereon as CHARLESTON SHORES BOULEVARD, SUMMERVILLE TERRACE, EDISTO DRIVE, MOULTRIE DRIVE and SANTEE TERRACE are hereby dedicated to the BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, for the perpetual use of the public for proper purposes.

LAKE TRACTS 1, 2, 3, 5 and 6, as shown hereon, are hereby dedicated to the LAKE CHARLESTON MAINTENANCE ASSOCIATION, INC., a Florida Corporation not for profit, for lake and water management purposes and are the perpetual maintenance obligation of said association, its successors and assigns, without recourse to Palm Beach County.

3) DEVELOPMENT TRACTS:

- a. TRACTS A, B, H through Z, inclusive, and AA, as shown hereon, are hereby reserved for the fee simple owners thereof for residential development purposes and are the perpetual maintenance obligation of the said fee simple owners thereof without recourse to Palm Beach County. Said tracts must be replatted prior to development.
- b. TRACT G, as shown hereon, is hereby reserved for the fee simple owners thereof for residential development purposes, subject however to terms of Section I(B)(2)(B) of Resolution No. R-86-1928 of Board of County Commissioners of Palm Beach County, Florida, whereby 7.5 acres of the northwest portion thereof are subject to be defined by and conveyed to the Florida Department of Transportation for Turnpike interchange purposes. The perpetual maintenance obligations of that portion of TRACT G usable for development purposes shall be that of the fee simple owners thereof, their successors, heirs and/or assigns, without recourse to Palm Beach County. That portion of said tract to be developed for residential purposes must be replatted prior to development.

CHURCH TRACTS 1 and 2, as shown hereon, are hereby reserved for the fee simple owners thereof for the construction and operation of church facilities and are the perpetual maintenance obligation of the said owners thereof, their successors, heirs and/or assigns, without recourse to Palm
