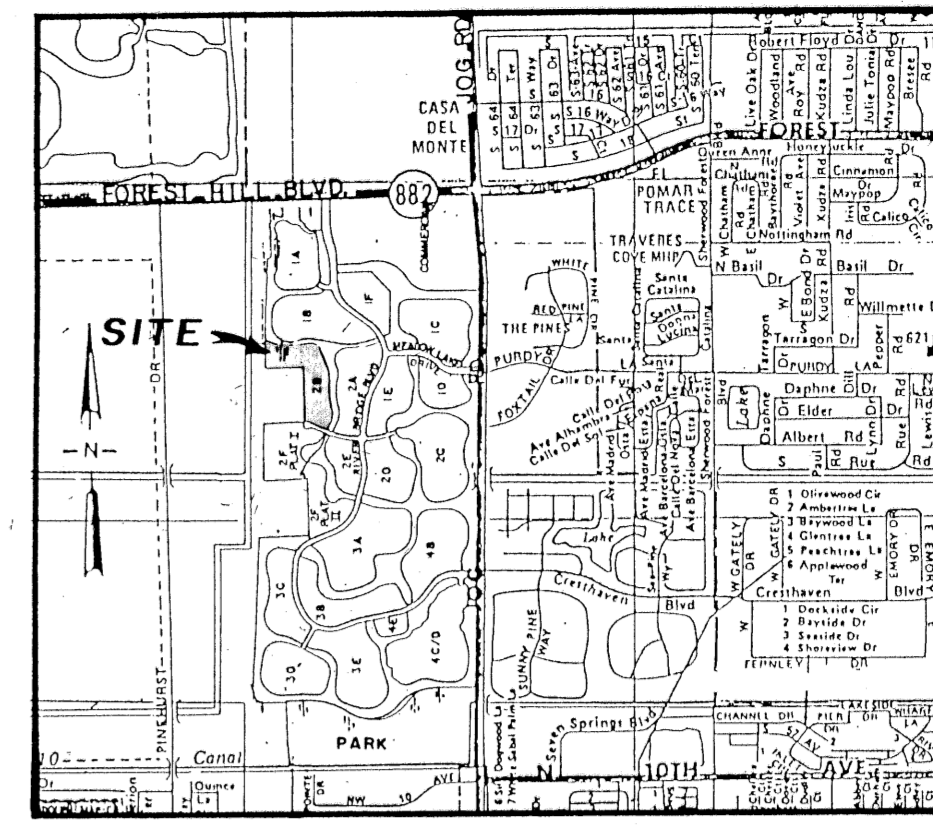

**DEDICATION**

KNOW ALL MEN BY THESE PRESENTS, that the RIVER BRIDGE CORPORATION, a Delaware Corporation licensed to do business in the State of Florida, the owners of the land shown hereon as RIVER BRIDGE P.U.D. PARCEL 2B, situate in Section 15, Township 44 South, Range 42 East, City of Greenacres, Palm Beach County, Florida, being a replat of Parcel 2B, RIVER BRIDGE P.U.D. PLAT 2, according to the plat thereof as recorded in Plat Book 56, pages 197 through 200 of the public records of Palm Beach County, Florida, being more particularly described as follows:

BEING all of Parcel 2B, of RIVER BRIDGE P.U.D. PLAT 2, according to the plat thereof as recorded in Plat Book 56, pages 197 through 200 of the public records of Palm Beach County, Florida.

The above described parcel of land contains 478,861.782 square feet (10.99315 acres) more or less.

Have caused the same to be surveyed and platted as shown hereon and do hereby dedicate as follows:

1. Tract A, the access tract as shown hereon, is hereby dedicated in perpetuity to and shall be the perpetual maintenance obligation of THE SOUNDINGS HOMEOWNERS' ASSOCIATION AT RIVER BRIDGE, INC., its successors and assigns, for ingress and egress, utilities and drainage. However, RIVER BRIDGE PROPERTY OWNERS' ASSOCIATION, INC., its successors and assigns shall have the right of access through Tract A, to the drainage easements.
2. The Utility Easements as shown hereon, are hereby dedicated in perpetuity for construction operations, maintenance, inspection, replacement and repair of utilities, cable television or security facilities and appurtenances, by any public utility, cable television or security service. The property owner shall maintain the property on, over, or under which the utility easements are located.
3. The Water Management Tract, as shown hereon, was previously dedicated as a Water Management Easement per RIVER BRIDGE P.U.D. PLAT 2, as recorded in Plat Book 56, pages 197 through 200 of the Public Records of Palm Beach County, Florida and is hereby rededicated in perpetuity to the RIVER BRIDGE PROPERTY OWNERS' ASSOCIATION INC., its successors and assigns, for the construction and maintenance of drainage facilities.
4. The 20 foot Lake Maintenance Easement, as shown hereon, is hereby dedicated in perpetuity to the RIVER BRIDGE PROPERTY OWNERS' ASSOCIATION INC., its successors and assigns, for the construction and maintenance of drainage facilities.
5. The Drainage Easements as shown hereon, are hereby dedicated in perpetuity to, and shall be the perpetual maintenance obligation of the THE SOUNDINGS HOMEOWNERS' ASSOCIATION AT RIVER BRIDGE, INC., its successors and assigns, for the construction and maintenance of drainage facilities. The RIVER BRIDGE PROPERTY OWNERS' ASSOCIATION, INC., its successors and assigns shall have the right of access through the drainage easements to the water management easement.
6. The 15 foot Drainage Access Easement, as shown hereon, is hereby dedicated in perpetuity to, and shall be the perpetual maintenance obligation of the RIVER BRIDGE PROPERTY OWNERS' ASSOCIATION, INC., its successors and assigns, for access to and the construction and maintenance of drainage facilities.
