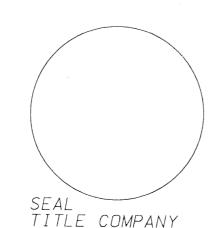

3. There shall be no trees, shrubs, or landscaping placed on water and sewer easements or drainage easements, except as shown on the approved final development plan and/or

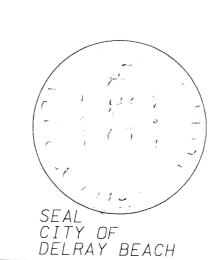

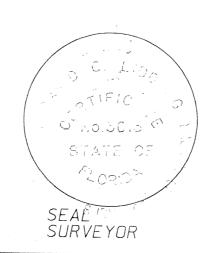
