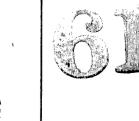

CONTAINING 207,900 SQUARE FEET OR 4.7727 ACRES, MORE OR LESS.

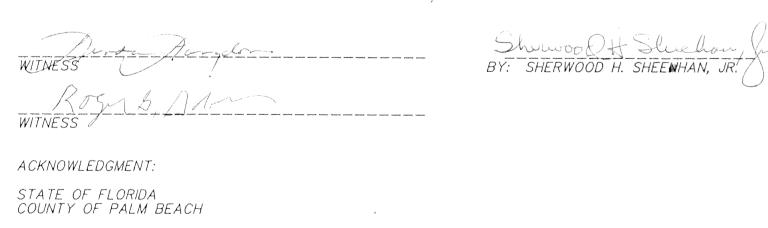

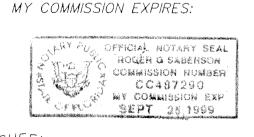
